

LINN COUNTY SAR ACADEMY – June 20th

CMRU has been asked to help on Monday, June 20th, with two phases of training at Linn County’s SAR academy. As we have done for the past several years, we have been asked to present *Map and Compass* training in the morning and rappelling in the afternoon. If you would be available to assist with the afternoon session, contact Bob Freund. The rappelling session will start shortly after 1300 at the Lebanon Fire Department drill tower and should conclude by 1700. It will involve rigging rappel and belay lines, instructing recruits how to “hook up,” and belaying them on rappel.

DOCUMENT REVISION – update

With the splitting of Trainee membership into Full Deployable (FD and Limited Deployable (LD) levels, the *Constitution and Bylaws* and the *Requirements for Membership* documents needed to be revised. Matt Crawford has completed the revisions and they were presented to the Executive Committee for a “first reading” at its May 31st meeting. The revisions were discussed and modified a bit. Matt has circulated a draft to the Executive Committee and the latest version will soon be posted in the “members only” area of the website for all members to view. If you have comments or suggestions, they may be forwarded to the Executive Committee through the Member-at-Large (Lindsay Clunes) or to Matt directly. The revisions will be finalized at the June 27th meeting of the Executive Committee. If there are no substantial changes to what Matt produced, the revisions may be adopted at the June Executive Committee meeting, otherwise it will have to wait through another 30 day comment period.

On another matter regarding updating documents, the Executive Committee has discussed reformatting chapter nine of the *Procedures Manual* dealing with Technical Evacuation to include photographs rather than line drawings. Since the manual is now distributed on CD, inclusion of actual photographs will be easier than in the past. But we would need to set up a structured “photo shoot” to get detailed pictures that show just (and only) what we want to show – no distracting background or shadows obscuring details.
